Physical Protection of Category 1 and Category 2 Quantities of Radioactive Material:
Petition for Rulemaking (PRM); Notice of Docketing and Request for Comment
(PRM-37-1; NRC-2014-0172)

On October 28, 2014, the NRC published a document in the *Federal Register* (79 FR 64149) regarding a PRM from Anthony R. Pietrangelo on behalf of the Nuclear Energy Institute (the petitioner) dated June 12, 2014. The petitioner requests that the NRC amend its regulations to "remove unnecessary and burdensome requirements on licensees with established physical security programs." The petition was docketed by the NRC on July 17, 2014, and has been assigned Docket No. PRM-37-1. Comments are due by January 12, 2015.

Meeting with International Atomic Energy Agency

On October 14-17, 2014, the staff participated in a technical meeting with the International Atomic Energy Agency in Shanghai, China. The purpose of the meeting was to work on the coordinated research project for the qualification, condition monitoring, and management of aging of low voltage cables in nuclear power plant life management. The goal of this project is to provide the current fleet of reactors and the next generation of nuclear facilities with information and guidelines on how to qualify cables, monitor the performance of existing cables, validate the condition monitoring methods used by the industry and establish a program of cable aging management. During the meeting, the staff listened to numerous technical presentations on low voltage cable testing and cable condition monitoring, as well as provided input during working group sessions.
