To whom it may concern,

The manufacturer BST ProControl GmbH (former betacontrol GmbH)("BST ProControl"), the current 100% shareholder of betacontrol of America, Inc. ("betacontrol"), is in the process of selling 100% of betacontrol shares to Markus Hannig.

As a result, the control of the License will be transferred from BST ProControl to Markus Hannig.

The Licensee's corporate name, mailing address, and contact information, including phone numbers will remain unchanged.

No changes of personal or duties related to the licensed program will take place. Markus Hannig is the current Radiation Safety Officer for betacontrol.

No changes are intended in the location, facility, equipment, radiation safety program, use, possession, and waste management, or other procedures that relate to the license program.

All equipment containing byproduct material is drop shipped by BST ProControl to end user.

No licensed material was processed at the facility not allowing any contamination to take palce, not requiring performing any leak tests, area surveys, wiping test, training, quality control and related records and for that matter doesn't require any record keeping

The Radiation Safety Program remains in effect unchanged.

There will be no revision to the licensee's decommissioning funding plan and supporting financial assurance documents.

The facility in which betacontrol holds an office, has never handled licensed material, documenting of survey of ambient radiation levels and fixed and/or removable contamination is therefore not required.

All records concerning the safe and effective decommissioning of the facility will be transferred to the transferee or to the NRC, as appropriate. These records include documentation of surveys of ambient radiation levels and fixed and/or removable contamination, including methods and sensitivity.

Both transferor and transferee agree to transferring control of the licensed material and activity, and the conditions of transfer, and that the transferee has been made aware of any open inspection items and its responsibility for possible resulting enforcement actions.

The transferee will abide by all constraints, conditions, requirements, representations, and commitments of the transferor or that the transferee will submit a complete description of the proposed licensed program.
