NOTIFICATION OF CHANGE IN LICENSED OPERATOR STATUS

Gentlemen:

Carolina Power & Light (CP&L) Company submits the attached Certification of Medical Examination by Facility Licensee (i.e., NRC Form 396) and the examining physician's medical statement for a licensed Senior Reactor Operator at the H. B. Robinson Steam Electric Plant (HBRSEP), Unit No. 2. The individual's name, license number, and docket number is provided in Attachment I to this letter. The NRC Form 396 is being submitted in accordance with 10 CFR 55.25 and 10 CFR 50.74 to reflect a change in licensed restrictions for the referenced individual and as provided as Attachment II to this letter. The licensee's routine medical examination determined that he is to be restricted to the use of corrective lenses while performing licensed duties. The NRC Form 396 is being transmitted to Region II only. This notification was required to be submitted by October 26, 1996. However, due to an oversight, it was not submitted at that time.

In accordance with 10 CFR 2.790(a)(6), CP&L requests the information in the attachments be withheld from public disclosure because the attachments contain personnel and medical files, the disclosure of this which would constitute a clearly unwarranted invasion of personal privacy. Accordingly, the attachments are being transmitted directly to Mr. Thomas A. Peebles, Chief, Operations Branch, NRC Region II Division of Reactor Safety.
