On October 16, 2014, the U.S. Nuclear Regulatory Commission (NRC) completed an inspection of the physical security program for the Zion Independent Spent Fuel Storage Installation (ISFSI) located in Zion, Illinois. The purpose of the inspection was to verify that the security program and protection for the ISFSI was in compliance with the NRC approved ISFSI Physical Security Plan (PSP), Safeguards Contingency Plan (SCP), Training and Qualification Plan (T&QP), NRC regulations with approved exemptions, and NRC Security Order EA-11-268; in addition, the inspection also evaluated the handling and storage of safeguards information. At the conclusion of the on-site inspection on October 16, 2014, the inspector discussed the inspection findings with you, and members of your plant, security, licensing and ISFSI project management staff.

The inspection also examined activities conducted under your license as they relate to security and compliance with the NRC's rules and regulations and with the conditions of your license. The inspector reviewed selected procedures and records, observed activities, and interviewed personnel. The enclosed inspection report documents the inspection results.

Based on the results of this inspection, no findings of significance were identified.
