SUBJECT: DIRECT FINAL RULE TO REVISE THE 10 CFR PART 72 LIST

OF APPROVED SPENT FUEL STORAGE CASKS: NAC

INTERNATIONAL MAGNASTOR® SYSTEM, CERTIFICATE OF

COMPLIANCE NO. 1031, AMENDMENT NO. 4

Enclosed for your signature is a direct final rule, along with the companion proposed rule (Enclosures 1 and 2), amending the U.S. Nuclear Regulatory Commission's spent fuel regulations by revising the NAC International MAGNASTOR® System listing within the "List of Approved Spent Fuel Storage Casks" to include Amendment No. 4 to Certificate of Compliance No. 1031. Amendment No. 4 makes changes to the limiting condition for operation in the Technical Specifications (TSs) for spent fuel transfer and helium backfill times for the transportable storage canister. The Amendment also corrects a typographical error in two required minimum actual areal boron densities in Technical Specification Appendix A, Section 4.1.1(a). In addition, Technical Specification Appendix B, Table B2-5, establishes new minimum additional decay times for loading spent fuel that contains nonfuel hardware. The revised TSs are identified in the staff's Safety Evaluation Report for Amendment 4.
