SUBJECT: SUMMARY OF A PUBLIC TELECONFERENCE ON NOVEMBER 6,

2014, WITH MEMBERS OF THE AP1000 DESIGN CENTER TO

DISCUSS AP1000 LICENSING AND TECHNICAL ISSUES

The U.S. Nuclear Regulatory Commission (NRC) staff held a Category 2 public teleconference on November 6, 2014, at 2:00 p.m. with members of the AP1000 design center. The purpose of the meeting was to discuss AP1000 combined license (COL) issues. The list of attendees is enclosed. The meeting notice is available in the Agencywide Documents Access and Management System (ADAMS).¹ The meeting notice is also posted on the NRC public website.²

The meeting addressed proposed license condition language from the NRC staff and Duke Energy Florida (DEF), applicant for the Levy Nuclear Plant (LNP) Units 1 and 2 COL, related to DEF's Special Nuclear Material Physical Protection Plan (SNMPPP) describing the physical protection strategies for special nuclear material of low strategic significance.³ This license condition ensures that DEF will notify the NRC when the SNMPPP is ready for implementation, occurring no later than 120 days prior to shipment or receipt of special nuclear material of low strategic significance. This notification will allow the staff to inspect DEF's SNMPPP, and if a deficiency in the plan is detected, it will allow DEF to implement changes to address it before receipt of special nuclear material of low strategic significance.

The staff and DEF agreed that the version of the proposed license condition language as revised by DEF satisfies their needs. However, the staff noted that a license condition already appearing in the Levy COL application (i.e., appearing as license condition number 6 on page LC-8 of Part 10 of the COL application) may also meet the staff needs and that this matter was still under review.

During this investigation, WEC discovered an error in one of the spreadsheet calculations. DEF expects the change to have minimal effects on the Final Safety Analysis Report (FSAR). DEF informed the staff that WEC is working to resolve the calculation error and that WEC has not yet provided DEF a schedule for when the calculation would be complete. DEF will notify the staff when they expect to submit the calculation revision for staff review.

At the end of the meeting, there was an opportunity for the public to provide comments and ask questions. All comments and questions were addressed before ending the meeting.
