Dear Mr. Smith:

The U.S. Nuclear Regulatory Commission (NRC) has issued Combined License (COL) NPF-95 to DTE Electric Company¹ pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Section 52.97, "Issuance of combined licenses." This license was issued after receiving the report of the Advisory Committee on Reactor Safeguards dated September 22, 2014, and as authorized by the Commission's hearing decision dated April 30, 2015 (ADAMS Accession Number ML15120A040).

Enclosed is a copy of NPF-95 (Enclosure 1) including the Technical Specifications (Appendix A), the Environmental Protection Plan (Appendix B), and the Inspections, Tests, Analyses, and Acceptance Criteria (Appendix C) for Enrico Fermi 3. Please note that Attachment 1 to Appendix C for NPF-95 contains security-related information and as such is withheld from public disclosure. A related notice will be forwarded to the Office of the Federal Register for publication.

Two copies of Amendment No. 28 to Indemnity Agreement No. B-20 which cover the activities authorized under License NPF-95 are included as Enclosure 2. Please countersign both copies and return one signed copy to this office.
