SUBJECT: SUMMARY OF THE NOVEMBER 24, 2014, PUBLIC
TELECONFERENCE MEETING TO DISCUSS OPEN ITEMS AND
OUTSTANDING ISSUES RELATING TO THE NUCLEAR
INNOVATION NORTH AMERICA, LLC., SOUTH TEXAS PROJECT,
UNITS 3 AND 4, COMBINED LICENSE APPLICATION

On November 24, 2014, a Category 1 public teleconference was held between the U.S. Nuclear Regulatory Commission (NRC) and representatives of Nuclear Innovation North America, LLC. (NINA). The meeting notice was issued on October 22, 2014, and was documented in the Agencywide Documents Access and Management System under accession number ML14295A071. The purpose of the meeting was to discuss the NINA comments on the safety evaluation report (SER) to be presented to the Advisory Committee on Reactor Safeguards (ACRS) subcommittee on December 3, 2014, and the outstanding actions from previous ACRS subcommittee meetings. The following topics were discussed, followed by its outcome:

Chapter 22.2 SER Comments

NINA provided comments on the SER that will be presented to the ACRS subcommittee on December 3, 2014. These comments are editorial and typographic in nature and the staff agreed to these comments. Corrections had been made and the staff will advise the ACRS subcommittee, what and why the changes are made during the presentation. NINA also provided names of the staff that will attend the subcommittee meeting.

Open Phase Condition at the Unit Auxiliary Transformer

Our EEEB staff is reviewing Dr. Stetkar's request to verify the presence of the isophase bus duct in the design of the South Texas Project (STP), Units 3 and 4, offsite power systems. This topic will be discussed with Dr. Stetkar and the subcommittee during the December 3, 2014, meeting.
