# AUDIT OF NRC'S NON-CONCURRENCE PROCESS

### OIG-11-A-02

#### **Status of Recommendations**

Recommendation 4:	Make non-concurrence process training available in an on- demand format to all staff and managers.
Agency Response Dated October 31, 2014:	The agency's learning management tool, iLearn, will serve as a medium where NCP training will be routinely available to all staff and managers when they need it. The Office of Enforcement (OE) collaborated with the Office of the Chief Human Capital Officer (OCHCO) to create voluntary NCP on-line, on-demand training for all staff and managers. On October 17, 2014, the NCP training module was implemented in iLearn. The course name is "Non- Concurrence Process (NCP)" and the iLearn ID number is 137144.
	The NCP training module effectively communicates policies, objectives, responsibilities, authorities, requirements, and information to all employees that are essential human capital practices that help to ensure employees have the knowledge and skills to perform their job and accomplish the agency mission.
	In addition, the NCP training module is now highlighted on the <u>NCP Web page</u> . A new Web page has been added ( <u>Training and Outreach</u> ) that provides the NCP training iLearn ID number as well as more in-depth information related to the training knowledge check questions and answers. Also, the Web page invites staff to request NCP outreach at all hands meetings, management seminars, panel discussions or brownbag lunch events. All outreach participants and staff who take the online NCP training will receive credit in iLearn.
