Dear Mr. Hobbs:

This letter refers to the Decommissioning Nuclear Power Reactor Security Inspection conducted on November 3 - 6, 2014, at Crystal River Nuclear Power Plant Unit 3 (CR-3). The inspection examined activities conducted under your license as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your license. The inspectors reviewed selected procedures and records, observed activities and interviewed personnel. The enclosed inspection report documents the inspection results, which were discussed with you and other members of your staff on November 6, 2014.

Based on the results of the inspection, no findings of significance were identified.
