Testimony has been given:

*PSEG also is working with a company on designs for a new type of “small, modular reactor” with fewer parts, a simpler design, deep underground containment and waterless cooling features.*

*Although recycling water systems and cooling towers would be required for any new conventional reactors, a permit fight is expected in 2015 over renewal of the more-than 3 billion gallon per day cooling water intakes for Salem Units 1 and 2. Environmental groups have argued that any increase in cooling water withdrawals from the Delaware River will worsen already large aquatic life losses caused by existing demands.*
