
Near-Term Task Force Review of Insights from the Fukushima Dai-ichi Accident (Reference 1). Reference 1 requested an assessment of the onsite and augmented staff needed to respond to a large scale natural event and implement identified mitigating strategies.

In Reference 2, Exelon Generation Company, LLC (EGC) provided the Limerick Generating Station Phase 2 Staffing Assessment Report addressing the functions and strategies related to Fukushima Near-Term Task Force Recommendation 4.2 and NRC Order EA-12-049 (Reference 3). The Limerick Generating Station Phase 2 Staffing Assessment Report considers the use of onsite security personnel as supplemental staff resources available to assist with the implementation of mitigating strategies following a Beyond-Design-Basis-External-Event (BDBEE) event. The supporting basis and evaluation related to use of security personnel during a BDBEE event is provided in Attachment 1 to this letter.

Attachment 1 contains Safeguards Information. Therefore, EGC requests that this information be withheld from public disclosure in accordance with 10 CFR 2.390, "Public inspections, exemptions, requests for withholding," paragraph (a), and 10 CFR 73.21, "Protection of Safeguards Information: Performance requirements," paragraph (a)(1)(i).
