On November 20, 2014, the U.S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at your Virgil C. Summer Nuclear Plant, Unit 1. The inspection also documents evaluation and closure of commitments specified in Confirmatory Order EA-12-140, dated March 10, 2014. The results of this inspection were discussed with Mr. R. Haselden, and other members of your staff, on November 20, 2014.

No findings or violations of more than minor significance were identified during this inspection.
