SUBJECT: COMPLETION OF CONFIRMATORY ORDER ACTIONS

Dear Mr. Goold:

The purpose of this letter is to acknowledge receipt of your electronic mail messages received since our previous communication with you dated June 26, 2013. In those communications, you provided the NRC with information that corresponded to actions required by the Confirmatory Order issued to you by the U.S. Nuclear Regulatory Commission (NRC) on October 10, 2012. Specifically, you provided the NRC with notification of your acceptance of employment with an Agreement State licensee, in accordance with Section V.B.1 of the Confirmatory Order; weekly notification of where you would be performing radiography, or if you would not be working, in accordance with Section V.B.2 of the Confirmatory Order; and you provided a copy of the Confirmatory Order to your employer in accordance with Section V.B.3 of the Confirmatory Order. You also provided the NRC copies of the semi-annual audits performed by your employer, in accordance with Section V.B.4 of the Confirmatory Order.

The NRC had previously reviewed the documentation you had provided associated with Sections V.B.5, V.B.6, and V.C of the Confirmatory Order as discussed in our letter dated June 26, 2013.

Finally, we determined that the two-year prohibition period mentioned in Sections V.A.1 and V.A.2 of the Confirmatory Order has satisfactorily expired.

We have determined that the information submitted in the aforementioned correspondence and the information previously provided to the NRC fulfills the requirements of the Confirmatory Order issued to you on October 10, 2012. Additionally, you have satisfied the prohibition terms of the Confirmatory Order. Therefore, the NRC has determined that you have met all the terms of the Confirmatory Order, and we consider this matter to be closed.

In accordance with Title 10 of the *Code of Federal Regulations* (10 CFR) 2.390, "Public Inspections, Exemptions, Requests for Withholding," of the NRC's "Rules of Practice," a copy of this letter and your response, if you choose to provide one, will be available electronically for public inspection in the NRC's Public Document Room or from the Publicly Available Records (PARS) component of the NRC's Agencywide Documents Access and Management System (ADAMS).
