**Triad Isotopes - Warren, MI (CN584812)**

1. In the 2<sup>nd</sup> (and 8<sup>th</sup>) paragraphs of your letter dated 09/10/14, it indicates that the courier employer will furnish evidence of initial and recurrent training on an annual basis.

Please confirm that Triad will maintain these records for inspection by the NRC.

2. In the 3<sup>rd</sup> paragraph of your letter dated 09/10/14, it indicates that "Triad shall periodically inspect the courier vehicles..."

Please clarify how often these inspections will be conducted by Triad and confirm that documentation will be maintained.

3. In the 6<sup>th</sup> paragraph of your letter dated 09/10/14, it indicates that the courier employer will be responsible for providing dosimetry and monitoring dose if necessary.

If dosimetry is provided, will Triad reserve the option to request dosimetry records for review and maintain said records for future NRC inspection?
