Re: Notification of Transaction – Norwalk Hospital (NRC License Number: 06-06941-01)

Dear Ms. Nguyen:

I am writing on behalf of The Norwalk Hospital Association d/b/a Norwalk Hospital in connection with a corporate transaction (the "Transaction") involving the Norwalk Health Services Corporation and Western Connecticut Health Network, Inc. ("WCHN") that occurred on, and is effective as of, October 1, 2014. In submitting this letter, I am acting in my official capacity as the President of Norwalk Hospital, a position I assumed on November 3, 2014, and pursuant to this letter I am providing notice to the NRC of my replacement of Daniel DeBarba, Jr. as President of Norwalk Hospital. My assumption of the position of President of Norwalk Hospital was not related to the Transaction, and no additional organizational changes occurred as a result of the Transaction. Upon receipt of this letter by the NRC, I request that I be listed as the NRC contact person for Norwalk Hospital for billing and any other necessary purposes.


Reference is made to that certain notification letter dated September 23, 2014, sent on behalf of WCHN and Norwalk Hospital by Brian D. Nichols, Esq., of Robinson & Cole LLP. In accordance with your request dated November 19, 2014 for confirmation of the contents of the notification letter, I hereby certify and endorse on behalf of Norwalk Hospital, holder of NRC License Number 06-06941-01, all statements and representations concerning the Transaction contained in Mr. Nichols' letter.

In addition, attached please find organizational charts depicting the corporate structure of WCHN prior to, and upon completion of, the Transaction. The Transaction constituted a corporate restructuring of entities within WCHN, and there was no financial remuneration involved nor were any assets transferred to parties outside of WCHN. Norwalk Hospital will continue to operate under the same name, and does not use any licensed materials under an alias. Therefore, it is Norwalk Hospital's understanding that the Transaction does not constitute a change of control under NRC regulations.

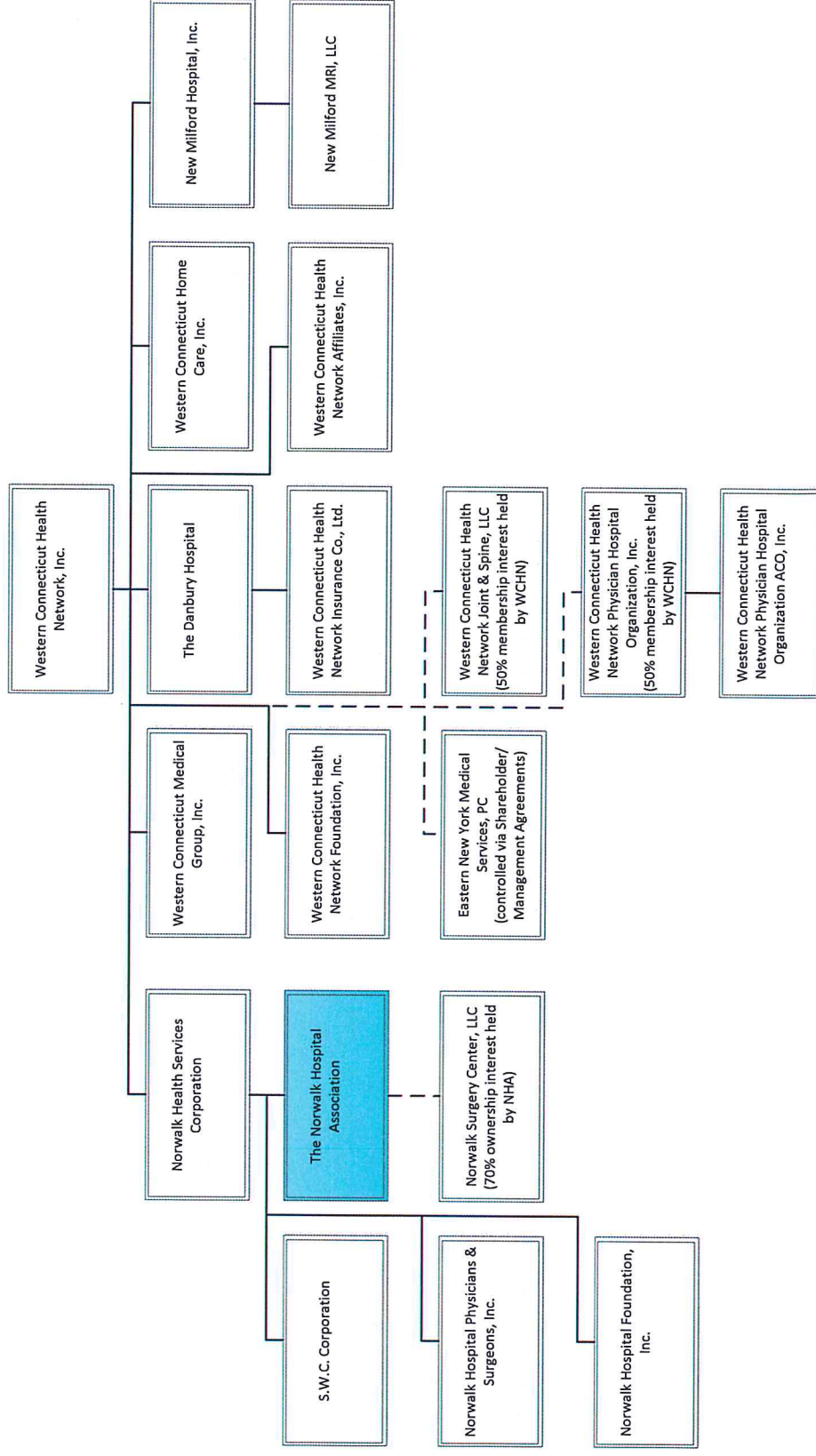
