- 1. Any use of sealed sources and devices will be used in accordance with that outlined on the Sealed Source & Device Registry certificates
- 2. Mr. Williams has had training on several dates over the past 15 years but after completing the RSO course and talking to Danny Smiley the week of November 24, 2014 the training on the safe practices and routine maintenance of our plant gauges was completed.
- Before using licensed materials, authorized users will have successfully completed one of the training courses described in Criteria in the section entitled 'Authorized Users' in NUREG-1556, Vol. 4, 'Consolidated Guidance about Materials Licenses: Program-Specific Guidance about Fixed Gauge Licenses,' dated October 1998."
- 4. We will use instruments that meet the Criteria in the section entitled 'Radiation Safety Program-Instruments,' in NUREG-1556, Vol.4, dated August 1998 and "Each survey meter will be calibrated by the manufacturer or other person authorized by the NRC or an Agreement State to perform survey meter calibrations
- 5. We will perform a prospective evaluation demonstrating that unmonitored individuals are not likely to receive, in one year, a radiation dose in excess of 10% of the allowable limits in 10 CFR Part 20 or we will provide dosimetry that meets the Criteria in the section entitled 'Radiation Safety Program Occupational Dosimetry,' in NUREG-1556, Vol. 4 dated October 1998."
- 6. The gauge manufacturer, distributor or other person authorized by NRC or an Agreement State will perform non-routine operations such as installation, initial radiation survey, repair, and maintenance of components related to the radiological safety of the gauge, gauge relocation, replacement, and disposal of sealed sources, alignment, or removal of a gauge from service.
- 7. The use of fixed gauges at temporary job-sites is not applicable to our program. We will not use fixed gauges at temporary job-sites.
