The following information is provided regarding the change of control of Monroe Hospital NRC License # 13-32773-01) following the previously reported bankruptcy proceedings:

1. This is a change of ownership, with transfer of assets, from Monroe Hospital LLC to Prime Health Services - Monroe, LLC, tax ID 47-2105584, continuing to do business as Monroe Hospital. If further information is needed, please contact Janice Wampler, Controller, at 812-825-0797.
2. There are no changes in personnel or duties that relate to the licensed program.
3. There are no changes in the organization, location, facilities, equipment or procedures that relate to the licensed program.
4. The surveillance program (surveys, wipe tests, quality control) has been maintained in compliance through bankruptcy and will be in compliance at the time control is transferred.
5. All records concerning the safe and effective decommissioning of the facility will be transferred to Prime Health Services - Monroe LLC. These records include documentation of surveys of ambient radiation levels and fixed and/or removable contamination, including methods and sensitivity.
6. The transferee (Prime Health Services - Monroe LLC) will abide by all constraints, conditions, requirements and commitments of the transferor (Monroe Hospital LLC).

7. The signatures below provide documentation that Monroe Hospital LLC and Prime Health Services LLC agree to the change in ownership of the licensed material and activity, the conditions of transfer, and that there are no open inspection items for which Prime Health Services - Monroe LLC would be responsible for possible resulting enforcement actions.
