STATUS REPORT

In accordance with the Atomic Safety and Licensing Board's (Board) Initial Scheduling Order,¹ the NRC staff (Staff) is providing the Board with the Staff's sixty-fourth Status Report. There are no changes from last month's status report.

The Staff completed the Advanced Final Safety Evaluation Report (AFSER) on September 15, 2011, and the Staff met with the AP1000 ACRS Subcommittee on October 18-19, 2011. The Staff met with the full committee of the ACRS on December 1-2, 2011. The ACRS letter that includes the results of the ACRS review of the AFSER was issued on December 7, 2011 and is available on ADAMS (ML11339A126). After the Staff met with the ACRS, the Staff determined in SECY-12-0025 that certain recommendations from the Fukushima Near-Term Task Force should be implemented for new reactors prior to licensing. The staff issued an additional Chapter 20 of the AFSER addressing these issues on December 13, 2012, and the Staff subsequently presented its review of the Fukushima-related seismic reevaluation to the ACRS AP1000 Subcommittee on January 18, 2013.

At that time, the Staff had scheduled dissemination of the Final Safety Evaluation Report (FSER) by September 2013. However, due to newly discovered issues, the staff revised the schedule two additional times and, most recently, notified the applicant that a schedule could not be prepared because the applicant has not provided information needed to resolve several outstanding issues (ADAMS Accession Number ML14323A198).

For the environmental review, as stated in the Staff's August 5, 2010 Status Report, the Staff publicly released the Draft Environmental Impact Statement (DEIS) on August 5, 2010 and sent it to the Environmental Protection Agency on August 6, 2010. The Staff made the final Environmental Impact Statement publicly available on April 27, 2012.
