**Human Resources (HR) Services**

On December 18, 2014, as a result of a competitive procurement, a General Services Administration labor-hour Task Order No. GS-15F-0070K; NRC-HQ-84-15-T-0001 was awarded to FPMI Solutions, Inc., in Madison, Alabama. This contract is to provide human resource services for the Office of the Chief Human Capital Officer. The period of performance is January 1, 2015, through December 31, 2020, inclusive of base period and four 1-year option periods. The total estimated ceiling cost is \$3,232,908, inclusive of all options.
