Dear Mr. Ramsey:

This is a follow-up to the letter which Ms. Margie A. Kotzalas, U.S. Nuclear Regulatory Commission (NRC), sent to you. This letter, dated August 20, 2013, informed you that the NRC would be issuing new Sealed Source and Device (SS&D) registration certificates to replace the ones which had been issued previously by the Georgia Environmental Protection Division (GAEPD) because the authority to issue Sealed Source and Device registrations has been transferred from the GAEPD to the NRC.

In reference to the letter, dated September 28, 2013, to transfer the registration certificate GA-0716-D-103-S to inactive status. This certificate has been transferred to inactive status as requested. A copy of the inactivated registration certificate NR-0716-D-803-S is enclosed. Furthermore, please note that we are also working on issuing new registration certificates to replace your other GAEPD certificates, and we will transmit these new certificates accordingly once they are complete.
