On November 18, 2014, the U.S. Nuclear Regulatory Commission (NRC) held a Category 2 public teleconference with representatives from Duke Energy Florida and Westinghouse Electric Company (WEC) to discuss the status of issues to support the safety review for the Levy Nuclear Plant Units 1 and 2 combined license application (COLA) (Agencywide Documents Access and Management System (ADAMS) Accession No. ML14318A341). One of the issues discussed was an error that WEC discovered in a proprietary WGOTHIC calculation related to the condensate return analysis.

On December 16, 2014, NRC held a non-public meeting with WEC and AP1000 licensees and license applicants to find proprietary details of WGOTHIC calculation error and the impact (see ADAMS Accession No. ML15007A073). Please provide the following for the NRC staff to be able to better evaluate the impact of this error on Levy COLA:

- 1. Describe the error.
- 2. Describe the effect of this error on the condensate return analysis.
- 3. Describe and justify any changes made to the analyses to compensate for the effect of this error.
- 4. Confirm that this error does not affect the containment peak pressure and temperature calculations.
- 5. State when the corrected calculations will be available for NRC staff audit, if needed.
- 6. State whether Levy will submit amendments to previous submittals as a result of this error and if so, when will Levy make those submittals.
