> 1. Do you want to be licensed for just the Troxler model 3430, 3440, and 4640-B?  
>  
> We only purchase and use Troxler Models portable density gauges.  
> Yes, we would like to have our NRC license reflect that.  
>

> 2. Did you have the Troxler Model 3242 portable gauges in NRC jurisdiction? If so, please submit leak tests or state that leak tests were negative (needs to be a signed submittal).

> We do not have Troxler 3242 Asphalt Content gauge. We are not planning to purchase one at this time or in the near future.  
> Hence, leak testing is not required for this gauge model.

> 3. What activity value do you wish to be licensed for items 8.A. and 8.B.? The same as currently licensed?  
>  
> We currently have 24 Troxler Portable Density gauges. We would like to add one or two more Troxlers in next 4 years.  
> So, If we stay with 25 gauges, with material licensed quantity what we have currently,  
> we will be fine. If we get some the limit raised to add five more gauges in next 10 years, it will be great.  
> This way, it will not require any amendments until next renewal.
