Discussion: I asked Dr. Peterson, when this amendment needed to be issued. He said that I could issue when the action is ready. I asked if Dr. Steven should be authorized for other than carbon 14. He stated that he would like to have him authorized for all isotopes. I asked for experience with other radionuclides or additional training like a 40 hour course. He said that he didn't have that and agreed for authorization for just carbon 14. I discussed the need for a management contact to sign that they reviewed and concurred with the amendment request. Dr. Peterson said that the management contact, Dr. Magnarelli has left the licensee and a new Director was assigned.

Action Required: Have the new management contact of the licensee submit a letter stating that they have reviewed and concurred with the amendment request dated December 4, 2014.
