Waiver\_Purpose: UCS's Center for Science and Democracy (CSD) is updating a report issued in 2013 on social media policies among federal government agencies, including the NRC. CSD requests documents on social media policies from the NRC and received records referring to the two requested documents, but not the documents themselves. The records obtained by CSD are more guidance and implementation in nature rather

than policy documents. UCS seeks the two requested documents for insights into social media policies at the NRC as CSD updates its report.

Waiver\_ExtentToExtractAnalyze: As indicated in the response to question 1 above, UCS's CSD examined social media policies and reported findings in 2013. CSD seeks to update that effort/report.

Waiver\_SpecificActivityQuals: UCS's CSD has scientists and analysts well versed in federal policy-making and analysis. CSD will review the requested documents, along with documents on the same subject from other federal agencies, to assess how social media policies are established.

Waiver\_ImpactPublicUnderstanding: Unlike the reports I develop for UCS, our CSD examines issues like social media policies as administered by numerous federal agencies. That wider perspective allows CSD to identify leaders and laggards. Because CSD's reports rank performance from high to low, the reports receive widespread attention by the media and activists.

Waiver\_NatureOfPublic: CSD's results are reported to UCS's 400,000-plus supporters and posted to our website where many more see them.

Waiver\_MeansOfDissemination: CSD will likely prepare a short report and associated web commentary about the social media policies at federal agencies.

Waiver\_FreeToPublicOrFee: Reports posted to our website, <a href="www.ucsusa.org">www.ucsusa.org</a>, are available for viewing/downloading free of charge, as are commentaries posted to our blogs.
