Meeting Facilitation and External Outreach Support Services

On January 1, 2015, as a result of an 8(a) non-competitive solicitation, an Indefinite-Delivery-Indefinite-Quantity Enterprise-Wide Contract No. NRC-HQ-7M-15-E-0001 was awarded to Centeva, LLC, in South Jordan, Utah. The contract provides for facilitation and outreach support services for external and public meetings. The period of performance is January 1, 2015, through December 31, 2015, with three 1-year option periods. The total estimated ceiling is \$887,847, inclusive of all options.

Tenable Nessus Security Center

On January 5, 2015, as a result of a non-competitive solicitation, fixed-price task order number NRC-HQ-10-15-T-0001 was issued under Scientific and Engineering Workstation Procurement (SEWP) Contract NNG07DA22B to Blue Tech, Incorporated in San Diego, California. The contract provides for Tenable Nessus Security Center license and maintenance for real time monitoring of NRC's networks to protect against outside threats and attacks. The period of performance is January 5, 2015, through January 4, 2018. The total ceiling price is \$181,461.
