

In Reference 4, UUSA requested additional changes to the exemption request submitted in Reference 1. Reference 4 requested 10 CFR 2.390 withholding. UUSA has evaluated this further and determined not to request 10 CFR 2.390 withholding. As such, UUSA requests that Reference 4 be withdrawn and replaced with this letter.

In Reference 1, UUSA requested exemption to allow phased decommissioning funding during construction of the facility. In Reference 2, UUSA provided responses to the NRC's Request for Additional Information (RAI), Reference 3. This supplemental document is to submit additional SAR changes supporting Reference 1 and the response to RAI question 2. Specifically, for SBM-1005 and future SBMs, UUSA will provide financial assurance prior to placing an Assay into service rather than prior to placing an SBM into service as was completed for SBM-1001 and SBM-1003. This change is necessary due to the extended time period between placing each assay into production. The Enclosures show the additional changes to the Reference 1 request.
