Meeting Facilitation and External Outreach Support Services

On January 1, 2015, as a result of an 8(a) non-competitive solicitation, Indefinite-Delivery-IndefiniteQuantity Enterprise-Wide Contract No. NRC-HQ-7M-15-E-0001 was awarded to Centeva, LLC, in South Jordan, Utah. The contract provides for facilitation and outreach support services for external and public meetings. The period of performance is January 1, 2015, through December 31, 2015, with three 1-year option periods. The total estimated ceiling is \$887,847, inclusive of all options.
