Dear Administrative Judges:

In its Order dated March 5, 2009, the Atomic Safety and Licensing Board (“Board”) directed the NRC staff (“Staff”) to tender each month a status report advising as to whether the estimated dates for issuance of the final Safety Evaluation Report (“SER”) (predicted for the late summer of 2009) and the final environmental review document (predicted for December of 2009) have changed.¹ On July 26, 2013, the Staff informed the Board and the parties of the public availability of the SER. The SER can be accessed electronically via ADAMS Accession Number ML110820512.

By letter dated November 26, 2014 (ADAMS Accession No. ML14343A708), the Staff received a request from the licensee to prioritize work on the amendment application for the Marsland Expansion Area. After reviewing Staff resources to accommodate this request, the Staff now expects to be able to issue the final environmental review document in this matter by the end of December 2015. In keeping with the Board’s mandate, the Staff will tender its next monthly status report by February 16, 2015.
