
The purpose of this letter is to amend our current NRC license to reflect the following changes, effective February 1, 2015. We are requesting a Transfer of Control amendment, and new tax identification number. Please find the enclosed information pertaining to both matters enclosed.

**Item #1:** We are requesting a transfer of control of Mercy Hospital Grayling to Munson Healthcare Grayling Hospital effective February 1, 2015 (the "Effective Date"). All equipment and sealed sources will be transferred as of the Effective Date upon approval of this amendment. We have included the required information for this transfer for your review. Our name is changing, but our location will remain the same.

**PER INFORMATION APPENDIX G, NUREG-1556, VOL. 9, REV. 2**

1. Transfer of assets by sale will be made. The name of the facility will be Munson Healthcare Grayling Hospital.
2. All personnel and authorized users will remain the same. The Radiation Safety Officer will remain Robert L. Balestrero, M.D.
3. Munson Healthcare Grayling Hospital will obtain possession of all nuclear medicine cameras, radioactive materials, sealed sources and radiation safety equipment. The location will remain the same, 1100 E. Michigan Avenue, Grayling, MI 49738.
4. All required documents and records are currently kept in accordance with the NRC license condition. These include, but are not limited to the annual calibration of survey instruments, semi-annual leak testing of non-exempt sealed radioactive sources, radiation monitoring and personnel exposure monitoring reports. Radiation monitoring is performed on a daily basis for acceptable radiation levels and weekly for removable contamination.


The areas of storage, preparation, handling, and administration of radioactive materials are surveyed daily for acceptable radiation levels and weekly for removable contamination. If contamination of these areas is detected during these daily or weekly surveys, decontamination is undertaken and completed at that time.


5. Due to the small quantities and short half-lives of the unsealed radioactive materials, which we use, we are exempt from showing financial assurance for decommissioning. We do not use any unsealed radioactive materials with a half-life greater than 60 days and there are no open inspection items.
6. All parties involved with the transfer are aware of and agree to the planned transfer of ownership. Please see the enclosed, signed agreement page.
