
Dear Ms. Forster,

Hi Ms. Kuhnenn:

Thank you for the update.

I checked the Sealed Source & Device Registry for the device registered under IL-1266-D-101-G. Based on information contained in the registry, the device may be distributed by Krones for use under a General License. Accordingly, you would not be required to hold a specific NRC license (as you applied for in late 2014) in order to possess and use the Krones Checkmat 700 Series device. That device would be subject to NRC registration requirements, however, which require annual reporting to the NRC, via our headquarters office. Typically, the initial transfer information and registration documents are provided to the NRC by the manufacturer/distributor, and the NRC will follow up with you for any details needed to complete the application.

If you intend to receive the device under the general license, and wish to withdraw your application for a specific license, please send a signed and dated letter confirming the same. You may send the letter as a scanned-in pdf file, attached to an email. Please submit your response by Friday, January 16th. I will be in the office tomorrow afternoon, if you have any questions regarding this message. Do not hesitate to call and/or email me.
