Dear Mr. Dalton:

This refers to your license amendment request dated December 10, 2014. Enclosed with this letter is the amended license. As I explained to you during our telephone conversation of January 6, 2014, the new storage location for licensed material is not listed on your NRC license as an authorized location because it is outside of NRC jurisdiction.

Please note that documents submitted to the NRC may be made available to public. Therefore, you should not include facility diagrams or any personally identifiable information in your future submittals. The NRC will contact you if such information is needed for our review.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
