Sybase Maintenance Renewal Support

On January 9, 2015, as a result of a non-competitive solicitation, a fixed-price delivery order number NRC-HQ-10-15-T-0001 was issued under General Services Administration Schedule GS35F5212H to SAP National Security Services, Incorporated in Newtown Square, Pennsylvania. The contract provides for the renewal of Sybase license and maintenance support for NRC. The period of performance is January 1, 2015, through December 31, 2015, with one 1-year option period. The total price ceiling is \$320,738.72, inclusive of the option.

Improved Identification Techniques Against Alkali-Silica Reaction Concrete Degradation at Nuclear Power Plants; Petition for Rulemaking (PRM); Docketing and Request for Comment; 10 Code of Federal Regulations Part 50 (PRM-50-109; NRC-2014-0257)

On January 12, 2015, the NRC published a notice of docketing and request for comment in the *Federal Register* ([80 FR 1476](#)) of a PRM filed on September 25, 2014, by Sandra Gavutis on behalf of C-10 Research and Education Foundation (the petitioner). The petitioner requests that the NRC amend its regulations to provide improved identification techniques against Alkali-Silica Reaction concrete degradation at nuclear power plants. Comments are due by March 30, 2015.

Department of Energy/Electric Power Research Institute (DOE/EPRI) Cable Meetings

On January 12-13, 2015, staff participated in DOE/EPRI electrical cable research meetings supporting subsequent license renewal. The purpose was to discuss technical issues and ongoing research on electrical cables and condition monitoring test methods. Additional discussions centered on obtaining naturally-aged cables from decommissioned plants (Zion, Crystal River, etc.) for use in electrical cable research as well as NRC's update on electrical cable aging management programs for subsequent license renewal. On January 14-16, 2015, staff participated in the Electric Power Research Institute Cable User's Group meeting, which included discussions on medium voltage cable failures, lessons learned in qualification of cables, fiber optic cable qualification, low voltage insulation susceptibility to wet environments, condition monitoring test methods, and cable operating experience.
