Dear Mr. Cartoski:

We have reviewed the Georgia license condition that was submitted to address 10 CFR Part 37 received by our office on January 15, 2015. The license condition was reviewed by comparison to the equivalent U.S. Nuclear Regulatory Commission (NRC) rules and the requirements of the one amendment identified in the enclosed State Regulation Status (SRS) Data Sheet. We discussed our review of the regulations with you on February 11, 2015.

As a result of our review, we have one comment that has been identified in the enclosure. Please note that we have limited our review to the license condition and Georgia regulations required for compatibility and/or health and safety. We have determined that if Georgia's regulations are revised, incorporating our comment and without other significant change, they would meet the compatibility and health and safety categories established in the Office of Nuclear Material Safety and Safeguards (NMSS) Procedure SA-200, "Compatibility Categories and Health and Safety Identification for NRC Regulations and Other Program Elements."

We request that when you revise your regulations to address our comment, a copy of the revised regulations be provided to us for review. As requested in NMSS Procedure SA-201, "Review of State Regulatory Requirements," please highlight the location of any changes made by Georgia, in response to our comment, and provide a copy to Division of Material Safety, State, Tribal, and Rulemaking Programs, NMSS.

The SRS Data Sheet summarizes our knowledge of the status of other Georgia regulations, as indicated. Please let us know if you note any inaccuracies, or have any comments on the information contained in the SRS Data Sheet. This letter, including the SRS Data Sheet, is posted on the NMSS website: <u>http://nrc-stp.ornl.gov/rulemaking.html</u>.
