Dear Dr. Lodhi:

Verso Corporation (“Verso”),¹ on behalf of its indirect, wholly owned subsidiaries, NewPage Holdings Inc. (“NewPage”) and Luke Paper Company (“the Licensee”), hereby notifies the U.S. Nuclear Regulatory Commission (“NRC”) of the completion of an indirect transfer of control of the above-captioned license. By letter dated May 5, 2014, the NRC approved the indirect transfer of control resulting from a merger between NewPage and a Verso subsidiary as described in a January 31, 2014 letter.

On January 7, 2015, Verso and NewPage closed on the merger described in the January 31, 2014 letter. Both NewPage and the Licensee are now indirect, wholly owned subsidiaries of Verso. Accordingly, Verso hereby notifies the NRC that the approved indirect transfer of control is complete.
