As directed by Order EA-14-190 STP Nuclear Operating Company (STPNOC) hereby submits information in response to the Order for Implementation of Additional Security Measures and Fingerprinting for Unescorted Access for South Texas Project Electric Generating Station (STPEGS) Independent Spent Fuel Storage Installation (ISFSI) hereinafter "(Order)".

STPNOC consents to the Order and does not request a hearing.

Upon implementation, STPNOC will be able to comply with the requirements described in Enclosure 1, Attachments 1 and 2 of the Order and implementation of the requirement will not cause STPNOC to be in violation of the provisions of any Commission regulation or the facility license. Implementation of the requirements described in Enclosure 1, Attachments 1 and 2 of the Order will not adversely impact the safe storage of spent fuel. The first movement of spent fuel to the STPEGS ISFSI is currently scheduled to begin in June 2016.

STPNOC will immediately start implementation of the requirements in Enclosure 1, Attachments 1 and 2 of the Order and will be completed by December 30, 2015.


