**Microsoft Premier Support**

On January 15, 2015, as a result of a non-competitive solicitation, fixed-price delivery order number NRC-HQ-10-15-T-0001 was issued under General Services Administration's schedule GS35F0791N to New Technology Solutions, Incorporated in Fremont, California. The contract provides for expert Microsoft Premier technical support for new and existing Microsoft technologies introduced and currently in the NRC computing environment. The period of performance is January 16, 2015, through January 15, 2016. The total price ceiling is \$172,616.

On January 22, 2015, the NRC published a final rule in the *Federal Register* ([80 FR 3147](#)) amending its spent fuel storage regulations by revising the Transnuclear, Inc. Standardized Advanced NUHOMS® Horizontal Modular Storage System listing within the "List of Approved Spent Fuel Storage Casks" to include Amendment No. 3 to Certificate of Compliance No. 1029. On April 15, 2014, the NRC published a direct final rule ([79 FR 21121](#)) and a companion proposed rule ([79 FR 21156](#)) on this amendment. The NRC withdrew the direct final rule on June 25, 2014, ([79 FR 35911](#)), because it received significant adverse comments. The comments received on the companion proposed rule are addressed in this final rule. This final rule will become effective on February 21, 2015.

**Institute of Electrical and Electronics Engineers (IEEE) Nuclear Power Engineering Committee (NPEC) Meetings**

On January 19-22, 2015, the staff participated in the IEEE NPEC meeting. Staff contributed to standards related to: 1) Equipment Qualification; 2) Operating, Aging, Maintenance, Testing and Reliability; 3) Auxiliary Power; 4) Human Factors and Control Facilities; and 5) Safety Related Systems. Significant topics included degraded voltage relays, open phase design vulnerability in electric power systems, joint standard on equipment qualification, qualification of electrical cables, and criteria for diesel generator units as standby power supplies.
