I am writing in response to your request for information regarding the renewal application of Complete Health Systems, License No. 21-32543-01, Docket No. 030-36714. 1 will answer your questions below:

- 1. Mr. Craig VanHouten was approved by the management to sign the renewal application on their behalf.
- 2. The mobile service takes the radioactive material and imaging camera into the doctor's offices. After the studies are completed and all radioactive materials are removed from the office, the doctor's office is surveyed with a GM meter and wipes performed.
- 3. No PET radiopharmaceuticals are used by this company.
- 4. The Imaging room at the address 5084 Villa Linde Pkwy is marked Exam #2. This is the same room in which patients are injected with radiopharmaceuticals for the rest studies.
- Radioactive materials are delivered to the stationary site at 5084 Villa Linde or to the trailer when a technologist is present.
- 6. The licensee provides personnel dosimetry devices to those meeting "criteria" in NUREG-1556, Volume 9, Rev. 2.
- 7. The licensee has developed and implemented and maintained written procedures for area surveys in accordance with 10CFR20.1101 that meet the requirements of 10CFR20.1501 and 10CFR35.70.
