Dear Ms. Opila:

We have reviewed the final revisions to the legislation to amend the Colorado Radiation Control Act received by our office on January 29, 2015. The legislation was reviewed by comparison to the Atomic Energy Act of 1954, Section 274; 10 CFR Part 40, "Domestic Licensing of Source Material"; 10 CFR Part 61, "Licensing Requirements for Land Disposal of Radioactive Waste"; and the Suggested State Legislation on "Radiation Control," published 1983 by the Council of State Governments.

Please note that we have limited our review to program elements required for compatibility and/or health and safety and the identification of program elements that create conflicts, duplications or gaps in the orderly pattern of regulations on a nationwide basis (See the 1997 Policy Statement on Adequacy and Compatibility of Agreement State Programs).

We note that Colorado became an Agreement State on January 1, 1968 and amended their Agreement to include Section 11e.(2) material of the Atomic Energy Act on April 20, 1982. During the negotiations for both the Agreement and the amendment to the Agreement, U.S. Nuclear Regulatory Commission (NRC) reviewed Colorado's enabling legislation. Based on our review, we offer the following comments:

1. A) In the Bill Summary in the first paragraph, it states, "The federal nuclear regulatory commission (NRC) has primary jurisdiction over radioactive materials but has delegated that authority within Colorado to the state by agreement." This needs to be amended to state, "The federal Nuclear Regulatory Commission (NRC) has primary jurisdiction over radioactive materials but has relinquished that authority within Colorado by agreement."  
  
B) In the same paragraph, it states, "The audit report listed numerous amendments to Colorado's radiation control statute that are necessary to maintain the delegated authority." This needs to be amended to state, "The audit report listed numerous amendments to Colorado's radiation control statute that are necessary to maintain the state agreement."

2. In Section 1 under 25-11-101 under the definition for “BYPRODUCT MATERIAL”, it states in subsection 2, “Rules promulgated under this section must be consistent with United States Nuclear Regulatory Commission requirements necessary to maintain agreement state status and final regulations proposed by the Conference of Radiation Control Program Directors”. This needs to be changed to state, “Rules promulgated under this section must be consistent with NRC requirements necessary to maintain agreement state status and should be consistent with final regulations proposed by the Conference of Radiation Control Program Directors”.
3. In Section 3 under 25-11-107 in the first paragraph, it states, “Prior to the application of any numeric groundwater standard different from the baseline standard contained in 10 CFR Part 40, the standard must have been approved by the United States Nuclear Regulatory Commission in accordance with Section 274o of the Federal “Atomic Energy Act of 1954”, 42 U.S.C. Sec. 2021(o).” The term baseline standard is not a 10 CFR Part 40 term. The statement needs to be changed to state, “Prior to the application of any numeric groundwater standard different from the basic ground-water protection standards imposed by the Environmental Protection Agency in 40 CFR Part 192, subparts D and E, the standard must have been approved by the United States Nuclear Regulatory Commission in accordance with Section 274o of the Federal “Atomic Energy Act of 1954”, 42 U.S.C. Sec. 2021(o).”

We discussed our review of the legislation with Jennifer Opila on February 18, 2015.

It appears that you have addressed the comments outlined in the October 24, 2011 letter [Agencywide Documents and Access Management System (ADAMS) Number ML112630471]; however, we recommend that you address the three comments above concerning the authority provided to the Department under the 274b agreement with NRC. Colorado may resolve some of these comments through revision or interpretation of State law. Although NRC will review all submittals to determine acceptability, NRC may accept interpretations provided by the State Attorney General, or other attorney designated as legal advisor to the radioactive materials program.
