Dear Mr. Lawyer:

We are in receipt of your letter dated January 7, 2015, regarding the NRC's consent to transfer radioactive materials license no. 45-17195-01 (the "**License**") held by Marshall Miller & Associates, Inc. ("**MM&A**") to its parent company, Cardno, Inc. ("**Cardno**"), as part of an internal plan of restructuring of Cardno's corporate structure (the "**Plan of Restructuring**"). We understand that the NRC desires some signed documentation showing that the Plan of Restructuring has been finalized in order to issue an administrative amendment to the License.

The finalized Plan of Restructuring was adopted and implemented effective January 1, 2015. On that date, substantially all of the employees transferred from MM&A to Cardno. In connection therewith MM&A and Cardno executed applicable transaction documents. Attached is a copy of an Assignment & Assumption that reflects the assignment of assets, particularly as it relates to the License and any MM&A contracts that require the License whose transfer to Cardno was conditioned upon your approval. Accordingly, we respectfully request that you issue an administrative amendment to the License reflecting the transfer of License to Cardno.

**ASSIGNMENT & ASSUMPTION**

Pursuant to a plan of restructuring and related documents (the “**Plan of Restructuring**”), effective as of January 1, 2015 (the “**Effective Date**”), Marshall Miller & Associates, Inc., a Virginia corporation (“**Assignor**”), does hereby irrevocably assign, transfer and deliver, to its sole shareholder, Cardno, Inc., a Delaware corporation (“**Assignee**”), all of its rights, title and interest in the Assets of Assignor; provided, however, that with respect to (i) that certain license no. 45-17195-01 from the U.S. Nuclear Regulatory Commission and (ii) any radioactive materials contracts that require a license from the U.S. Nuclear Regulatory Commission, the transfer of such license and any such contract shall be effective upon receipt of consent by such agency to transfer such contract. Any employee serving as the radiation safety officer for Assignor shall continue to serve in such capacity as an employee of Assignee.
