# SUBJECT: NRC INSPECTION REPORT NO. 03008478/2014002, DEPARTMENT OF HEALTH & HUMAN SERVICES, NATIONAL INSTITUTES OF HEALTH, BETHESDA, MARYLAND AND NOTICE OF VIOLATION

Dear Ms. Newman:

On July 21-23, 2014, Kathy Modes of this office conducted an inspection at the above address of activities authorized by the above listed NRC license. The inspection continued in-office until January 14, 2015. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selective examination of representative records. Additional information provided in your correspondence dated August 12, 2014, and the telephone conversation on January 14, 2015, between Cathy Ribaudo of your organization and this office were also examined as part of the inspection. The findings of the inspection were discussed with Cathy Ribaudo of your organization at the conclusion of the inspection on January 14, 2015.

Based on the results of this inspection, the NRC determined that one or more violations of NRC requirements occurred. Because of the security-related nature of any such violations, the number and characterization will not be provided in this letter, but instead are provided in nonpublic enclosures. The violation(s) were evaluated in accordance with the NRC Enforcement Policy.
