This is in response to your phone call of this date at which time you requested that NRC be allowed to provide Governor James Hunt (N.C.) a copy of the management and technical capability material filed in response to Mr. H. R. Denton's June 29, 1979 request.

Although we maintain our opinion that this material is proprietary as defined by 10CFR2.79.0, we concur in your sending a copy to Governor Hunt. We would, however, appreciate your suggesting to the Governor, in your transmittal letter, the importance of not making this material public and asking that it not be disseminated beyond his staff.


We further understand that NRC will provide the Governor an evaluation of CP&L's management and technical capability to anticipate and preclude or respond to unusual nuclear events, and that this evaluation will be based on the material filed on August 16, 1979.

Recognizing the implications of such an evaluation, we would appreciate the opportunity to meet with you to review and discuss this evaluation prior to its being transmitted to the Governor.
