Mr. Kim:

Please provide a date by which you intend to provide the remaining information in response to our Request for Additional Information (RAI) dated December 11, 2014.

As stated in that RAI:

"We will continue our review upon receipt of this information. If we do not receive your reply within 30 calendar days from the date of this letter, we will consider your application as having been abandoned by you. This action would be without prejudice to the resubmission of another application with the required information. Note: Your letter stated that you have submitted a Radioactive Material License Application to the California Department of Public Health, Radiologic Health Branch, and it is being processed for licensing. Although we will continue our review, an exempt-distribution license will not be issued unless and until you have received the license from the State of California."

Although it is apparent that you have not abandoned your application, and do not intend to do so, it may be necessary to void your license application, depending upon how soon the requested information is provided. We have an internal deadline of 90 days for the processing of an application for a new license. That deadline is February 18, 2015. If you do not foresee getting a license from the State of California by that date, or if you cannot provide the additional requested information by February 4, 2015, it will be necessary to void you application and ask you to reapply when all of the information, including your California license, become available.
