In accordance with 10 CFR 72.140(d), "Previously-approved programs," Exelon Generation Company, LLC (EGC) is notifying the NRC of the intent to apply the previously approved Clinton Power Station (CPS), Unit 1 Quality Assurance Program to independent spent fuel storage installation (ISFSI) activities at CPS.

The CPS Quality Assurance Program, which satisfies the criteria of 10 CFR 50, Appendix B, is maintained in the EGC Quality Assurance Topical Report (QATR) (NO-AA-10), Revision 89. Revision 87 to the QATR was submitted to the NRC in Reference 1 for all EGC 10 CFR Part 50 Dockets. This included CPS, Unit 1 (i.e., NRC Docket No. 50-461).

In Reference 2, EGC requested NRC review and approval of proposed changes to the previously approved QATR Revision. In Reference 3, the NRC transmitted approval for the proposed QATR changes.
