SUBJECT: REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE
FOR PEACH BOTTOM ATOMIC POWER STATION, UNIT NOS. 2 AND 3
(TAC NOS. MF4760 AND MF4761)

Dear Mr. Hanson:

By letter dated February 6, 2015, Exelon Generation Company, LLC (Exelon) submitted an affidavit dated January 28, 2015, by GE-Hitachi Nuclear Energy Americas LLC (GEH) executed by Ms. Lisa K. Schichlein (Attachment 5 to Exelon's letter), to the Nuclear Regulatory Commission (NRC). Exelon requested that the information contained in Attachment 3 to its letter be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Section 2.390. Specifically, Exelon requested that the following document be withheld:

Responses to Containment and Ventilation Branch Requests for Additional
Information (Proprietary)

A non-proprietary copy of the document (Attachment 4 to Exelon's letter) has been placed in the NRC's Public Document Room and added to the Agencywide Documents Access and Management System Public Electronic Reading Room.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (4)a. Information that discloses a process, method, or apparatus, including supporting data and analyses, where prevention of its use by GEH's competitors without license from GEH constitutes a competitive economic advantage over other companies; and
- (4)b. Information that, if used by a competitor, would reduce their expenditure of resources or improve their competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing of a similar product.

In all review situations, if the NRC makes a determination adverse to the above, you will be notified in advance of any public disclosure.
