Dear Sir,

I am submitting the enclosed annual source material transfer report for the above Exempt Distribution License on behalf of Philips Lighting Technologies International (PLTI). This license authorizes PLTI to distribute lighting products containing thorium to persons exempt from licensing pursuant to Section 40.52, 10 CFR Part 40.

The attached report reflects material transfers for the full 2014 calendar year, even though PLTI was only licensed for a portion of this period. This is being done so, this first, and future annual material transfer reports are provided on a consistent calendar-year basis.

As has been past practice, and accepted by the NRC in prior, similar, byproduct material transfer reports, the attached report summarizes the source material transfers. If the NRC requires a description or identification of each product and model number transferred, this information can be provided. However, such information would be provided only as proprietary business information that must remain confidential. Public disclosure would expose confidential sales information to our market competitors who import/export/distribute similar products.

Additionally, PLTI has determined that the total number of units shipped is also confidential business information. Therefore, two copies of this transfer report are provided for NRC review. One copy is designated as containing confidential business information, is for NRC review only, and should **not** be disclosed publicly. Public disclosure would expose confidential sales information to PLTI market competitors. The second copy of the transfer report, with the identified confidential
