SUBJECT: NEW STATE LIAISON OFFICER APPOINTMENT FOR MONTANA

Dear Mr. Livingston:

I am pleased to learn of your appointment as the State Liaison Officer to the U.S. Nuclear Regulatory Commission (NRC) for the State of Montana. I would like to take this opportunity to welcome you to your position and to provide some general information about the role of the State Liaison Officer in serving as the principal communications liaison between the NRC and your State.

The State Liaison Officer Program was established in 1976 in response to recommendations from the National Governors Association and other organizations to improve cooperation between the NRC and the States. The NRC relies on the Governor-appointed State Liaison Officers to provide the primary communication channel between the States and the NRC. The State Liaison Officer serves as the key person in the State to keep the Governor informed on issues under the NRC's jurisdiction (specifically matters addressing nuclear regulation, nuclear security, and radiological public health and safety), and provides the NRC with State information on these issues. I have included with this letter an NRC brochure – NUREG/BR-0520 “State Programs at the U.S. Nuclear Regulatory Commission” (Enclosure 1) – that describes some of the NRC's interactions with States, including the State Liaison Officer Program. Enclosure 2, “U.S. Nuclear Regulatory Commission State Liaison Officer Program” describes the program in greater detail, including responsibilities of the State Liaison Officer.

Also enclosed, you will find an NRC procedure – Management Directive 5.2 “Cooperation with States at Commercial Nuclear Power Plants and Other Nuclear Production or Utilization Facilities” (Enclosure 3). This directive contains the NRC's policy on cooperation with States and more detailed information about the State Liaison Officer program and responsibilities. I encourage you to review and become familiar with this document.

Communications

Mr. Bill Maier, our Regional State Liaison Officer in the NRC Region IV office, located in Arlington, Texas will be your main contact for routine communications. Mr. Maier will provide more detailed information about the NRC and the State Liaison Officer function and discuss any questions that you may have.

You will now start receiving copies of NRC documents and reports on a regular basis to keep you informed of matters that are of interest to your State. Also, the NRC conducts national State Liaison Officer meetings, usually every 2-3 years, and regional meetings as needed to discuss matters of mutual regulatory interest. The next national conference will be held in the fall of 2015.

I encourage you to visit the NRC's Web site at www.nrc.gov, where you will find information about the agency's mission and programs. The "Stay Connected" section (located on the left side of the main page) contains links to multiple social media tools that can help you stay informed of NRC-related news.
