SUBJECT: SUMMARY OF A PUBLIC MEETING WITH SOUTHERN NUCLEAR

OPERATING COMPANY AND SOUTH CAROLINA ELECTRIC & GAS

ON JANUARY 22, 2015

The U.S. Nuclear Regulatory Commission (NRC) staff held a Category 2 public meeting with Southern Nuclear Operating Company (SNC) and South Carolina Electric & Gas (SCE&G) on January 22, 2015. The purpose of the meeting was to discuss issues associated with the safety review of licensing actions for SNC's Vogtle Electric Generating Plant (VEGP), Units 3 and 4, and SCE&G's Virgil C. Summer Nuclear Station (VCSNS), Units 2 and 3.

The licensee stated that the changes were being made to meet AP1000 design criteria. They noted that no additional analyses has been performed because the mixing in the volume above the IRWST where the plume is released from the IRWST vents is too complex to be accurately modeled and it will not provide any significant new information. In addition, analysis was not necessary to meet the criteria in Updated Final Safety Analysis Report Table 6.2.4-6 which were developed to ensure appropriate igniters placement without the need to perform complex analysis.

The staff also asked questions regarding the proposed hydrogen igniter control related changes. Specifically, the staff asked why these changes were being proposed. The licensee stated that since the hydrogen igniters are not safety-related, fixed position controls for the hydrogen igniters are not provided in the Protection and Safety Monitoring System (PMS) and the hydrogen igniter signals are not processed through the PMS.
