Dear Mr. Wiza:

The U.S. Nuclear Regulatory Commission has corrected and re-issued your Registration Certificate NR-1370-D-102-G. The following typos and omissions were found in Registration Certificate NR-1370-D-102-G dated July 8, 2014.

1. The "References" Section (Page 8) referenced to RAM Services, Inc. application dated January 21, 2014, instead of RAM Services, Inc. application dated January 31, 2014,
2. The "Labeling" Section (Page 3), did not state the specific location of the label on the device, and
3. In the application RAM Services, Inc. stated that a similar gauge was evaluated and previously registered in Registration Certificate No. NR-1193-D-101-G. The "Prototype Testing" Section (Page 4) was written to reference that a similar gauge was evaluated in Registration Certificate No. NR-1193-D-101-G, however there was no reference to the specific gauge Model previously registered in NR-1193-D-101-G (now NR-8286-D-801-G).

To avoid misunderstandings, please use Registration Certificate NR-1370-D-102-G, dated February 24, 2015. A copy of the amended Registration is enclosed.

Please be advised that you must manufacture and distribute the product in accordance with the statements and representations contained in your application, with enclosures thereto, and the information set out in your registration certificate. As a general rule, you must request and obtain an amendment to the certificate before you make changes or modifications to the information submitted to obtain the certificate.

Please read over the registration certificate in its entirety and notify us immediately of any errors or omissions.

You are obligated to notify us promptly in writing should you decide to no longer manufacture, distribute, or offer service support for the product.
