**Aging Management Program (AMP) Implementation Observations**

February 10-11, 2015, NRR and the Office of Research sent staff to Salem/Hope Creek to observe the preparation and implementation of AMPs in accordance with their renewed licenses. In addition, industry provided an overview of the various research and development initiatives that are underway at Electric Power Research Institute and Oak Ridge National Laboratory facilities related to their Long Term Operations programs.

**Approval of Summer National Fire Protection Association Standard 805 (NFPA 805) Amendment**

On February 11, 2015, the staff approved the Virgil C. Summer Nuclear Station Unit 1 license amendment to transition to National Fire Protection Association Standard 805 (NFPA 805). This is the eighth non-pilot plant to transition to the risk-informed, performance-based fire protection rule. As part of the implementation of NFPA 805, the licensee is making safety improvements to reduce the risk associated with a fire, including replacement of the reactor coolant pump (RCP) seals, installation of circuit protection for selected circuits, and provision of an alternate back-up communication system. The licensee has already provided an additional high pressure pump/diesel generator to mitigate the loss of RCP seal cooling and installed incipient fire detection in the relay and upper cable spreading room.
